TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING

DEVON COUNTY COUNCIL hereby give **NOTICE** that:

On **SUNDAY 23 NOVEMBER 2025**
for a maximum of 5 days

Anticipated Finish **SUNDAY 23 NOVEMBER 2025**

No person shall cause or permit any vehicle to proceed or wait on the sections of Affected Roads.

MARRIDGE CROSS TO CALIFORNIA CROSS, UGBOROUGH & MODBURY , (FROM NEAR WITCHCOMBE BUNGALOW TO APPROXIMATELY 0.6 MILES SOUTHWARDS)
